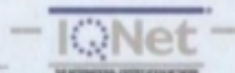

This is regarding the concern of Collera Enterprises, a client of Chaoan Micky Ceramic Co., Ltd. in the Philippines, that their ICC applications under Bill of Lading LH2104SMN091 is being held in abeyance by the Board of Philippine Standard / Board of Product Standard and being issued a Cause Order due to:

*“Upon evaluation and verification from the IQNET head office, it has been found out that Chaoan Micky Ceramics Co. Ltd. did not undergo certification with its partner CQC and with this, the ISO Certificate you submitted was found to be falsified. “*

This letter is to affirm that our client, Chaoan Micky Ceramic Co., Ltd, has been given the certification ISO9001-2008, GB/T 19001-2008, valid until 2023 by the Quality Management System. Chaoan Micky Ceramics Co. Ltd. is under our Quality Management Control until today.
